**WHEREAS**, the Walden Fire District and the Montgomery Fire District are each political subdivisions of the State of New York and as such have specifically defined boundaries;

**WHEREAS**, the Fire Districts are adjoining;

**WHEREAS**, it is in the best interest of the Fire Districts and their residents to alter the boundaries of the Fire Districts;

**WHEREAS**, Town Law Section 172 – a authorizes adjoining fire districts to alter the boundary of said districts:

**NOW, THEREFORE, THE BOARD OF FIRE COMMISSIONERS OF THE WALDEN FIRE DISTRICT AND THE MONTGOMERY FIRE DISTRICT, IN ORANGE COUNTY NEW YORK (THE “DISTRICTS”) HEREBY JOINTLY RESOLVE AS FOLLOWS:**
